### WAIVER, RELEASE AND HOLD HARMLESS AGREEMENT

1. Participate in fencing activities carried by the Halton Blades Fencing Club (HBFC) which include physical exercises, fencing instructions, fencing drills, fencing practice bouts and fencing competitions.
2. Use fencing equipment supplied by, procured through, and maintained or repaired by the HBFC and/or its officers, employees, instructors and members.

In consideration of my child's participation in the HBFC activities, I am waiving and releasing on my behalf and on behalf of my respective estates, successors and assigns, all claims for injuries and/or death arising out of, or in any way connected to the HBFC activities that might be sustained by my child and by signing this Waiver, Release and Hold Harmless Agreement, I agree as follows:

I recognize that there are certain risks of physical injuries and assume for my self the full risk of any injury, including death, which my child may suffer as a result of participation in any manner, in any HBFC activities, the use of his/her own fencing equipment, or fencing equipment provided by the HBFC or any person, or any other ancillary activities related thereto. I further acknowledge that all athletic activities involving strenuous exertion, potential body contact or potential contact with fencing weapons and equipment are activities which involve risks of injury.

To the extent permitted by law, I hereby waive and relinquish any and all claims that I may have as a result of my child's participation in the HBFC activities against the HBFC, its officers, instructors, members, employees, equipment suppliers, visitors and any other persons or entities including, but not limited to Ontario Fencing Association, Canadian Fencing Federation, their respective member clubs and any trustees, board members, owners, managers and operators and their respective employees of any real estate property in which the HBFC activities take place, including but not limited to the Milton Soccer Centre (all of the above-listed parties and entities are hereinafter referred to as the "Released Parties"), even if such Released Parties are or might be directly or indirectly by negligence in whole or in part responsible for any injuries, including death that my child might sustain while participating in the HBFC activities.

To the extent permitted by law, I further agree to save, indemnify and hold harmless the Released Parties from any and all claims for injuries including death, damages and losses sustained by any person or entity arising out of, connected with, or are in any way associated with or related to my child's participation and conduct in the HBFC activities.

Further, in any emergency I authorize any or all of the Released Parties to use any portable defibrillation equipment if reasonably available and if deemed necessary, or secure from any licensed hospital, physician and/or medical personnel, any treatment deemed necessary for immediate care, and I agree that I will be responsible for the cost of any and all medical services or treatments provided.

I acknowledge and agree that I understand the nature of the HBFC activities in which my child is participating and have read and fully understand this Waiver, Release and Hold Harmless Agreement.
